By signing and returning this Consent Form, I hereby agree that:

1. I am a parent or legally appointed guardian of the undernamed minor.
2. I have full authority to agree to, consent to, and enter into legally binding agreements on behalf of the undernamed minor.
3. This Consent Form shall be binding upon the undernamed minor, myself, and our respective heirs, legal representatives, and assigns.
4. The undernamed minor may participate in the Films for the Forest film festival, such as by submitting the Film.
5. I have read and understood the Films for the Forest film festival Rules and Regulations, the Films for the Forest website Terms and Conditions, and this Consent Form and, by signing

this Consent Form, fully agree to all terms set forth in the Rules and Regulations, the Terms and Conditions, and this Consent Form.

6 I will provide any information concerning myself or the undernamed minor that is required by Rainforest Partnership or Films for the Forest in submitting a film to the Films for the Forest film festival or in receiving a prize, if awarded.

In accordance with the Terms and Conditions, I hereby grant Rainforest Partnership and Films for the Forest a non-exclusive, non-transferable, irrevocable, worldwide, fully paid-up, royalty free license to all intellectual property rights in undernamed minor's Film, including the right to reproduce, publicly display, digitally transmit, and prepare derivative works of all or part of the Film, including the right to modify the Film, such as by including marks, logos, and/or other information relating to Rainforest Partnership and/or Films for the Forest on any portion of the submission.

8. I understand that the undernamed minor's Film, full name, and/or other information provided in connection with the Film may be posted on the Internet and/or displayed publicly in connection with the Films for the Forest film festival and as further described in the Rules and Regulations and Terms and Conditions.

9. Neither myself nor the undernamed minor shall make any claims against Rainforest Partnership or Films for the Forest based on the Film or on submission of the Film to the Films for the Forest film festival relating to the undernamed minor's capacity as a minor and/or inability of the undernamed minor to enter into legally binding agreements, and I release Rainforest Partnership and Films for the Forest, its employees, its directors, its sponsors, its licensees, and its assigns from any such claims.

10. This Consent Form and all activities relating to the undernamed minor's Film shall be governed by the laws of the State of Texas, United States.
